

# Minuteman Household Hazardous Products Committee Meeting Minutes 29 PM 2: 11 Tuesday, August 6, 2019

- 1. <u>Call to Order:</u> The meeting of the Minuteman Hazardous Products Facility Committee was called to order at 2:38PM.
- 2. Minutes: The meeting minutes from July 9, 2019 was reviewed and approved

### 3. July 20, 2019 Event Review:

- a. Concord Nancy from Concord reported on the July 20 collection event. Nancy advised that the event started just after 8:00 AM. Nancy advised that there were no major issues with any items brought to this event, the only issue was the intense heat. Nancy stated that it was a very busy event and it did not slow down the entire time which they kept the event open. Around 12:15 Seth from Clean Harbors suggested the event be closed early due to the intense heat, and multiple people having health issues in the line due to the heat. The call was made at 12:15PM to close the event early due to the heat, and Lexington police came to the Hartwell facility to help direct traffic and out of the facility. It was suggested that possibly adding a disclaimer to the bottom of the MHHP Event flyer stating that in extreme weather conditions the event may be closed, this could alleviate some of the issues arising from angry residents in situations where the events end up closing early due to weather
- b. <u>Clean Harbors</u> Krista reported that there was a high volume, and that the event went smoothly up until the early closure at 12:15PM.
