

The following information is provided to help you better understand your bill.

- A Account Information:** Customer name, statement number, account number, service address, and due date.
- B Messages:** Contains important information from BMLD, including ways to save energy, special events, holiday closing information, etc. Also contains customer/account specific messages as needed.
- C Energy Calculations:** Contains a breakdown of the current month charges according to kilowatt-hours of electricity used, the meter number and the dates of the previous and present readings, the appropriate rate class (i.e.: Residential A, Commercial).
- D Monthly Usage History:** Provides a customer-specific comparison of electric usage for a 12-month period. Includes usage in kilowatt-hours in graph form, as well with the number of actual kilowatt-hours used each month. This information can be used to determine which months the most electricity is used. Customers can also monitor the actual reading numbers from one month to the next, and see the per kilowatt-hour rates and/or credits for each charge related to your electric service. Information for BMLD customers with less than one year with BMLD will be listed according to the number of months of service.
- E Account Activity:** Includes previous balance, payments received and date recorded, and interest on past due amounts. Information regarding BMLD payment plan (payment plan amount, budget payment amount and the remaining balance of the annual payment plan) will also be included in this section.
- F BMLD Breakdown of Charges:** BMLD bills are unbundled, which means that the various charges, including generation, transmission and distribution are listed separately, along with the charges/credits on previously unbundled bills, i.e.: rate stabilization, energy conservation, appliance rebates, purchased power and NYPA hydro credit.
 - F1 Customer Charge.** This is a basic service charge that covers costs for billing, meter reading, equipment, and service line maintenance, among other administrative costs.
 - F2 Conservation Charge:** This charge is the result of the further unbundling of BMLD bills, enabling customers to get a more detailed look at the energy and distribution portion of their unbundled bill. The conservation charge of \$.0024 per kWh is used to fund energy conservation and incentive programs for BMLD customers.
 - F3 Distribution charge:** This is the cost of delivering electricity from the electric distribution network to your home or business over local electric lines.
 - F4 Generation charge:** This is the charge for electricity produced at the power plant.

F5 Transmission charge: The cost of transporting electricity from the power plant (the source of electric supply) to the distribution network (the Belmont/Cambridge line) over high voltage power lines.

F6 NYPA hydro credit: This is the amount of the charge or credit to BMLD for the purchase of hydropower from the New York Power Authority. These charges/savings are passed on to residential customers only up to the first 500 kWh.

F7 Additional Credits and Additional Adjustments: Any appliance rebates will be credited to the customer account.

Additional information in this section could include:

- Rate Stabilization Revenue, a charge that enables BMLD to set aside money into an account, much like a savings account, to pay for unexpected improvements and fluctuations in energy costs.
- Green Choice Program, which is an additional charge on the monthly bill of customers who voluntary sign up for the program to sustain and support the production of 100 kilowatt-hours from renewable energy sources in New England.

G Total Amount Due: Includes any past due charges, current charges, and the total amount due if paid by the due date.
