A. Director

B. Assistant Director

• New programs will begin April 1. Seniors will be grandfathered for discounts to Underwood pool use.

C. Bequest

• A bequest of \$10,000.00 was made to the Belmont Senior Center. There was some confusion about how the money would be accepted. The Friends of the Council on Aging voted to give the money to the COA to administer. A portion of the money will be earmarked for transportation.

D. Springwell

• Jane Shapiro discussed the subject of a merger between Springwell, which covers eight towns and Baypath, which covers fourteen towns. As an example of the similarity between the two organizations, both have almost the same qualifications for the case manager position.

E. Transportation working group

• The volunteer driver program will resume in April. Having learned from other communities about covid related safety guidelines for the program we are now waiting on Town Counsel to approve new waivers for participation in the program.

- F. The Town's Economic Development Committee the Committee has worked with the Urban Land Institute on development issues at Waverly Square.
- G. N. Niv-Vogel will follow up on the need to promote the Center in the Chinese community
 - N. Niv-Vogel briefly discussed the impact of rescinding the mask mandate: those who
 disliked wearing masks may now return to the Center; others, more concerned about Covid
 may stay away.
- H. Intergenerational Programming: T. Olson suggested that BHS should be contacted to establish relationships between the school/students and the Center.
