1. Approval of Prior Meeting Minutes

The minutes from BCC meetings held 9/30/20 and 1/5/21 were accepted.

2. <u>Treasurer's Report</u>

Annette Goodro reported the monies available for grant awards this year:

Annette noted that we are not holding back 5% for administrative costs this year, since we have sufficient from accumulated interest to pay for administrative costs this year.

3. BCC Website Status

Juliet reminded the group that we previously decided to extend maintain the BCC website through January '22. She recommends that at our first fall meeting this year we have a discussion to decide about the continuance of the website and the associated fees of approx. \$173.00/yr (\$20.00 for the domain name and \$153.00 for digital platform fees).

Juliet recommended we make it more obvious to visitors to the site what our main activity is. After making some updates to the website to reflect our new membership and events, she will send the team to the website and ask for brief feedback.

4. Updates from Chair

Status of Grants from FY '20 (delayed due to COVID19):

- The Greek dinner and Mae West presentation at the Beech Street Center are still on hold until it is safe for crowds to gather.
- The grant awarded to the Payson Park Music Festival for summer '20 will move to '21 to fund a performance by the same band.
- Habitat reconfigured their program to be Covid-safe and will move forward.
- The Belmont/Arlington Chorale will be presenting a virtual concert via YouTube in lieu of the in-person program they had planned for last December.
- Porchfest was not held in 2020 (future plan TBD).

Grant Cycle Timeline Nancy reported there were no changes to the grant cycle schedule.

Protocol for Reconsideration Requests/Denials Nancy reminded the group about the MCC guidelines for how to handle these and in what timeframe.

5. Discussion of Specific Awards for FY '21

Note that Rebecca Richards left the meeting while we discussed the grant request from the Belmont Gallery of Art.

We discussed the grants under consideration in detail and the merits of each, in order to award a dollar amount to each, summing to the \$8,370.00 we have available to award. We voted unanimously on the following grant allocations to eight projects:
