Outreach

Other business

- No news re McClean

- Phil Thayer reported that progress on the Chenery solar roof is blocked by the installer's not being allowed access to Belmont Light and the solar installers to the roof. School committee might be able to help

- Long-term capital committee member, Claus B, reported that a process is being developed to scan the horizon for upcoming projects and to prioritize them

according to various metrics, including adherence to strategies adopted by Town Meeting

- Travis F reported that the Structural Change Committee had met twice. Their mandate is to look for permanent ways to save Belmont money

- Travis F reported that the Lightboard Advisory Committee discussed how timeof-use charges could be used to support goal of strategic electrification. Also, the discussion of best use of the landfill site continues. Options for use depend on capping the site which is expensive. Once the area has been capped, ownership could be transferred to Belmont.

Support for climate bill S2295

The committee voted to support the passage of S2295, a landmark climate action bill that passed the legislature with clear support and was vetoed by the governor. The vote on giving James B and Marty B "authority to sign on to advocacy for s2295 Next Gen Roadmap for MA on behalf of Energy Committee." passed with three abstentions, zero "no" votes, and five "yes" votes.
