 Metro West Collaborative Development: Metro West Collaborative Development reviewed potential redevelopment options for Belmont Village that would include a redesign of the existing property. The redevelopment could potentially involve working with a private developer in order to create additional low income housing and may also incorporate affordable and market rate units.
