- 1. <u>Attendance</u>: The attendance was taken at 6:00 P.M. Commissioners Don Becker, Sallye Bleiberg, Ann Verrilli and Donna Brescia were present. Also present were the Executive Director, Donna Hamilton; Anne Allen from the League of Women Voters; and residents of Sherman Gardens Apartments. Commissioner Leo Saidnawey was absent.
- Meeting with Residents of Sherman Gardens Apartments: The repair/replacement of the
 outside steps was briefly discussed and some of the residents asked if the doors could be
 locked until the project begins. There was also an introduction to newly elected board
 member, Donna Brescia.
- 3. Reading and Approval of the Minutes of the Meetings:

-May 24, 2010 Annual and Regular Meeting: A motion was made by Don Becker, seconded by Donna Brescia, to approve the minutes of these meetings. The vote was unanimous (4). A motion was also made by Don Becker, seconded by Donna Brescia, to amend the minutes of the April meeting to reflect that the Director will confirm that the Authority does meet the threshold for the eligibility requirements for applying for Section additional non-elderly Section 8 Vouchers and that the Director and Commissioner Ann Verrilli will further discuss this matter prior to presenting it at the next meeting. The vote was unanimous (4).
