  - iii. UPBC is seeking a 'pool only' debt exclusion vote for the April 2014 election. Amount of dept exclusion TBD. Community Preservation Act Funds are also proposed to be used for this project.
- D. Skating Rink Snack Bar 3 year lease up in 2014. Current lease is \$2,000 for the rink season. Current operator (John Madden) would like to extend to two-three season operation but modifications to facility would be required. Current operator is not likely to bid on lease too far above current lease amount. RD would like to keep an active Snack Bar at rink. Provides necessary

service, enhances community, provides informal 'eyes' over facility safety. Low likelihood of another vendor bidding for operations.

- June to provide RC with estimated costs of Snack Bar renovation requested.
- II. New Business: Katy shared the 'Accessible Icon Project' with the group. The Project has been discussed with Sue Wiener.
  - June to show 'Accessible Icon Project' to Peter C. to consider for painting of parking spaces in the future at Town Rec facilities.
  - The Board confirmed that Anthony Ferrante would be nominated to serve as Recreation Commission liaison to the Community Preservation Act Committee to replace outgoing member John Owens.
