DEPARTMENT which have be	een adopted in cor	nformity with the provisions and
recommendations of the Man	ual on Uniform Tra	ffic Control Devices for Streets and
Highways published by the De	epartment of Trans	portation, Federal Highway
Administration, hereinafter ca	ied "STANDARDS	· "

WHEREAS, the DEPARTMENT proposed to reconstruct as a Federal Aid Project, portions of Trapelo Road and Belmont Street, being ways under control of the TOWN in the County of Middlesex, with work to be financed in part by the Federal Government; and

WHEREAS, the United States Government through its Department of Transportation, Federal Highway Administration, requires that the Project Area upon completion will be operated and maintained in a manner most adequate for anticipated traffic volumes and for the safety and convenience of pedestrians and vehicular traffic and shall be adequate to ensure the most efficient utilization of highways, bridges, or other facilities; and

WHEREAS, the TOWN approves the proposed plans for improvements and upon completion of the project a section of Belmont Street within the Town of Watertown will be the responsibility of the TOWN.

NOW THEREFORE, in consideration thereof, the DEPARTMENT and the TOWN hereby agree each with the other as follows:

I. GENERAL PROVISIONS – TRAFFIC DEVICES

- A. All information, traffic control signals, regulatory or warning signs, all pavement or other markings, or other traffic devices shall be designed, located and operated and maintained in accordance with the standards for such devices.
- B. The Police Department of the TOWN is the enforcement agency for traffic regulations established in accordance with this Agreement and the traffic devices installed in connection therewith.

C. Signed, dated and attested copies of Amendments to the TOWN traffic Rules and Regulations necessary for the enforcement of any specific provisions will be forwarded forthwith by the TOWN to the DEPARTMENT.

II. SPECIFIC PROVISIONS

A. STOP SIGNS (R1-1 SIGNS)

In accordance with applicable permits filed or to be filed by the TOWN and approved by the DEPARTMENT:

D. DO NOT ENTER (R5-1 SIGNS)

School Street for Northbound approach at School Street -	Approx. 1+75LT
School Street for Northbound approach at School Street -	Approx. 1+80LT

E. RIGHT TURN ONLY (R3-26 SIGNS)

Windsor Avenue for Northbound approach at Belmont St. - Approx. 122+10RT

III. MISCELLANEOUS

Traffic controls or regulations instituted whether by the DEPARTMENT or the TOWN on ways or parts thereof within the Federal Aid Project are to remain in force and effect until proposed future changes have been approved in writing by the DEPARTMENT.

The DEPARTMENT will not approve any future proposed traffic control changes within the Federal Aid Project which will in the opinion of the DEPARTMENT, lessen to any degree the efficient utilization of the highway for traffic purposes.

IV. MAINTENANCE

The TOWN, in accordance with the provisions of Sections 109(d) and 116 of Title 23 United States Code, will properly maintain the way and all traffic signs and pavement markings under the control of the TOWN within the project area.

V. PENALTY

Continued and willful failure on the part of the TOWN to fulfill its responsibility in the proper maintenance and operation and the enforcement of the traffic regulations of the completed project, may disqualify the TOWN from participation in future Federal Aid Projects in which the TOWN has maintenance responsibility, as provided in Title 23 USC.

Such failure shall result in the withholding or withdrawal of the unexpended balance of any funds assigned to the TOWN, under the provision of Chapter 90, Section 34, of the Massachusetts General Laws.
