Town of Belmont <u>Traffic Advisory Committee (TAC)</u>

Meeting Minutes October 11, 2018

Members present: Larry Macdonald (Chair), Dana Miller (Vice Chair), Peter Curro, Mary Gavin, Tomi Olson

The meeting was called to order at approximately 7:10 pm by TAC Chair Larry Macdonald.

Mr. Tim Flood addressed the TAC, requesting that the parking signage in front of his business at 458 Trapelo Road (East Coast Chip) be modified to allow one hour parking. Currently, parking is not allowed until 8:30 am and this is having a negative impact on his business and his customers. After discussion, including about one or two hour parking limiting all day commuter parking, unrestricted parking in the area and Mr Glenn Clancy's letter, upon Dana Miller's motion, it was moved, seconded and approved that one hour parking be established in front of 458 Trapelo Road for the standard Town hours of 8 am to 6 pm.

Butler School parent Azra Nelson raised concern about the lack of school zone signage, particularly around Dante Avenue and Maple Terrace and raised issues about no school zone signage on Trapelo Road and the lack of defined sidewalks. It was discussed and determined that conversations should be had with Mr. Clancy about the Butler petition, the school zone issues, a school crossing on Trapelo Road, and signs notifying drivers of children crossing or school in session.

Mary Gavin moved, the motion was seconded and unanimously approved that there be no parking here to corner at Trapelo Road near Sycamore, in the eastbound travel lane.

There being no further business, the meeting was adjourned at 8:22 pm.



I am requesting to add-to or change the parking spot signage at approximately 450 Trapelo Road (Across from the old fire station). Currently it states no parking before 830. The current signage was clearly to prevent commuter parking and/or allow an area for drop off of students on Trapelo that attend Butler Elementary. To date the active parking before 830 has not been enforced Even after many weekly emails since May 2017. Currently most spots are being used as all day commuter parking spots. I am a Belmont resident and I have a business on Trapelo Road. These spots specifically effect my business as well as the ability of consumers to frequent all the businesses in the area. I would like to see the no parking before 830 stay but would request all the spots be made consistent with the surrounding areas of 1 hour parking thereafter.

Lastly, it would be helpful in the mean time to have officers enforce the current signage.
