Stair 5 Steel Protrusion at Interior Finishes

Notes

Per architecture field report 101 dated 7/8/22, the structural steel stiffeners at level 2 of Stair 5 are protruding through the interior finishes. Canatal has produced FW056-B which proposes notching the existing stiffeners to avoid conflict with the interior finishes. In addition, RFI 1780 notes that there are 3 structural steel base plates protruding through the wall at Stair 5 and proposes to cut the base plates. Please reference Canatal FW 058 attached.

Neither the adjustments to the Contract Price nor the Contract Time upon which this PCO is based contemplates any project delays, suspensions, disruptions, cost escalations or other impacts caused, directly or indirectly, by the Pandemic (as defined in the GMP), as such cost adjustment to the Contract Sum and GMP shall be reconciled in accordance with the Owner Pandemic Allowance.
