The Board of Assessors met at 7:45 a.m. Mr. Clark & Mr. Laverty were present.

The minutes of the previous session were read. On motion by Mr. Clark, seconded by Mr. Laverty, passed unanimously, the minutes were accepted as read.

The following bills/vouchers were ordered paid:

Southern Computer Warehouse (Scanner)dated 06/17/2021JF Ryan Associates Inc. (FY21&FY22 Insp. & License fee) dated 06/14/2021Crystal Rock (water & delivery)dated 06/01/2021

The Board signed the Invoice Report dated 06/26/2021 for 3 invoices amounting to \$57,334.54.

The weekly list(s) of taxes exempted or abated was (were) signed: 6/11/2021 and 6/18/2021.

The Board signed the Assessors to Accounting Officer Notice of Commitment Fiscal Year 2022 Preliminary forms, Assessors Warrant to Collector for Real Estate Tax FY2022 Preliminary forms, and Assessors Warrant to Collector for Personal Property Tax FY2022 Preliminary Forms, in the amounts of \$53,947,374.89 for Real Estate Tax, \$483,974.16 for Personal Property Tax, and \$732,405.13 for the CPA Surcharge Tax.

The Board met with Mr. Floyd Carmen regarding uncollected taxes for Fiscal Year 2021. Mr. Carmen and the Board have been monitoring collections which showed higher than usual amount of delinquent or late tax payments. Through the work of Mr. Carmen and the Treasurer/Collectors office the amount of overdue tax payments is similar to prior year's collections at this time.

Given that there is not a larger than normal amount of delinquent tax payments the Board voted to release a portion of the Overlay (a fund used for abatements and uncollected taxes required by the Department of Revenue for each community) back to the general town fund in the amount of \$235,000.

On motion by Mr. Laverty, seconded by Mr. Clark, passed unanimously, the meeting adjourned at 9:30 a.m.
