The Board of Assessors met at 7:45 a.m. Mr. Reardon and Mr. Laverty were present.

The minutes of the previous session were read. On motion by Mr. Reardon, seconded by Mr. Laverty, passed unanimously, the minutes were accepted as read.

The Board opened the session to public participation.

There we no questions from the public.

The following bills/vouchers were ordered paid:

The Board signed the Invoice Report dated 1/27/2022 for four invoices amounting to \$ 250.60.

The weekly list(s) of taxes exempted or abated was (were) signed: 12/3/2021, 12/10/2021, 12/17/2021, 12/24/2021, 1/7/2022, 1/14/2022 and 1/28/2022. The taxes exempted totaled \$5,048.15.

The Board signed the FY2022: Assessors Warrant to Collector Real Estate Tax, in the amount of \$110,591,102.27; Personal Property Tax, in the amount of \$1,128,835.97; the Assessors to Accounting Officer Notice of Commitment; the Assessors Warrant to Collector Water Liens, in the amount of \$92,787.98; Sewer Liens, in the amount of \$130,507.16; Light Department Liens, in the amount of \$11,606.19; and Community Preservation Act Surcharge in the amount of \$1,972,454.86.

The Board signed the Assessors Warrant to Collector for Motor Vehicle and Trailer Excise for the Sixth Commitment of 2021, in the amount of \$20,265.70.

The Board signed the Assessors Warrant to Collector for Motor Vehicle and Trailer Excise for the First Commitment of 2022, in the amount of \$2,671,526.93.

The Board reviewed a letter sent by the residents of lower Goden Street regarding a recent installation of traffic lights and large increase in traffic volume due the recently completed first phase of the Belmont High School project. The installation has made Goden Street a primary drop off point for the high school on school hours.

The Board reviewed Clause 22D, a local property tax exemption for Veterans, regarding Surviving Spouses. The exemption would grant a full exemption from taxes for surviving spouses who died as a proximate result of a combat injury or disease or who are missing and presumed dead due to combat. The clause has been brought to the Board by Mr. Robert Upton, the Veteran's Services Office for the Town of Belmont.

Representatives for The Royal Belmont, 375 Acorn Park Dr, met with the Board Regrading upcoming Appellate Tax Board cases filed by Azure HGI Belmont LP.

The Board acted on twelve (12) applications for abatement of real estate and personal property taxes. Eight (8) were granted.*

On motion by Mr. Laverty, seconded by Mr. Reardon, passed unanimously, the Board went into executive session at 8:15 a.m. for the purpose of acting on applications for exemptions. The following applications were acted upon:*
