The Board of Assessors met at 7:45am Mr. Reardon, Mr. Laverty and Mr. Murphy were present.

The Board opened the session to public participation.

The minutes of the previous session were read. On motion by Mr. Murphy, seconded by Mr. Laverty, passed unanimously, the minutes were accepted as read.

The reviewed the contract presented from JF Ryan for Appraisal Services provided to the Town of Belmont for the next three fiscal years.

The Board voted to put forth the Senior Relief Legislation. The draft is to be entered as a home rule petition and a statewide petition to be presented to Belmont's State Representatives. Mr. Laverty motioned on both options which were seconded by Mr. Murphy and passed unanimously.

The Board appointed Mr. Patrick Murphy as the Board of Assessors representative on the MBTA Community Advisory Committee. Mr. Murphy is replacing former Board member Mr. Charles Clark.

The weekly list(s) of taxes exempted or abated was (were) signed: 3/17/2023. The taxes exempted totaled \$5,771.82.

The Board signed the Assessors Warrant to Collector for Motor Vehicle and Trailer Excise for the Second Commitment of 2023, in the amount of \$ 447,345.89.

The Board acted on twenty (20) applications for abatement of real estate and personal property taxes. fifteen (15) were granted. *

The voted to go into executive session to discuss pending litigation at the Appellate Tax Board brought forward by Belmont Country Club and to for the purpose of acting on applications for exemptions. The following applications were acted upon: *
