ACTION BY APPOINTMENT

Approval of Safe Routes Grant Application letter to MassDOT Feasibility Study

Ms. Jennifer Thomas, Burbank PTA President, appeared before the Board regarding the Safe Routes to School assessment. Dr. Thomas Kingston indicated that the School Committee was not required to vote on the Grant application letter to the Mass DOT; however the School Committee and the School Administration support the proposed letter and find it consistent with the overall plan to encourage walking to schools on safe routes.

The PTA of the Burbank, Butler, and Wellington Schools are participating in possible safe routes assessment/feasibility grant.

The Board moved: To approve the letter of municipal support as revised by Town Counsel for the Butler School PTA Safe Routes Grant Application for Mass DOT Feasibility Study and authorize the Town Administrator to sign the letter. The motion passed unanimously (3-0).
