## Approval of Water Rates

The Board of Water Commissioners and the Water Superintendent reviewed the proposal to adopt a rate of 3.387/100 ft<sup>3</sup>. It was noted that the rate is based upon a declining consumption average. Mr. Brownsberger noted that the consumption assessing may be too high based upon actual expenses in FY 2002.

It was noted that enhanced metering activity will probably have the effect of improving billable flow.

The Board moved: to adopt a rate of 3.87 per 100 ft<sup>3</sup>, to be reviewed after the first quarter billing period.

The motion passed unanimously (3-0). Discussion of Reserve Fund Transfer Requests
