Final Applications Update

Chimney Repair - \$125,000

CPC received the Town Hall Chimney study from Steve Dorrance for their review. Margaret Velie asked Lisa Harrington whether the HDC approved the project. Lisa Harrington stated HDC would not have a problem approving Town Hall Chimney project. Elizabeth Dionne asked whether there was any controversy approving this project. Andy Rojas noted that the purpose of the study was to know extent of the damage and the costs of the project.

Town Field Playground & Court Restoration - \$680,624

Margaret Velie stated that the Recreation Commission provided a letter of support for the Town Field Playground & Court Restoration. David Kane stated that the costs to maintain Town fields would come from the Town. The Recreation Commission looked into the appropriate use of

Town fields and not the cost of the project. David Kane reiterated that the Recreation Commission is not looking at the cost of the project. Floyd Carman suggested asking Jay Marcotte, DPW Director, a year from now the cost of maintaining Town fields. Roy Epstein stated that if the override fails that Jay Marcotte may not be able to maintain the fields.

Homer House Window Restoration Project - \$100,000

Elizabeth Dionne continues to wait for the deed agreement for the Homer House Cupola from Town Counsel. Margaret Velie asked Lisa Harrington whether HDC will provide CPC with a letter of support for Homer House Window Restoration Project. Roy Epstein stated that the letter recommending approval of the project didn't not have the language regarding the 10% contribution. Margaret Velie noted that the total project cost is \$110,000 and that the CPA grant funding request is for \$100,000. A revised letter will be emailed to Wendy Murphy that the first \$10,000 will be paid by the Women's Club.

Andy Rojas moved to approve Elizabeth Dionne as Chair of the Community Preservation Committee, and Margaret Velie as the Vice Chair of the Community Preservation Committee, passed unanimously.
