Final Applications Update

Homer House Window Restoration Project - \$100,000

Elizabeth Dionne asked whether the revised final letter was sent out to Wendy Murphy that 10% or \$10,000 of the Women's Club funds will be spent first before any of the CPA grant funds. Margaret Velie suggested that information be included in the final letter that goes out after Town Meeting approval.

Long Term Capital Planning Committee - Community Preservation Committee

Elizabeth Dionne stated that the Long Term Capital Planning Committee is seeking representative from CPC. Stephen Pinkerton stated that it will be interesting to have a member from the Planning Board. Floyd Carman gave some background sample of addressing the long term needs for town buildings and assets. Stephen Pinkerton stated that this will be an opportunity for Gloria Leipzig to be on the committee. Elizabeth Dionne stated that the deadline has passed and that CPC needs to appoint someone now. Stephen Pinkerton stated that he will be attending the initial meetings as a place holder. Elizabeth Dionne stated that Stephen Pinkerton will be the designee. Roy Epstein stated that the charge for the Long Term Capital Committee is to make recommendations, not policy decisions.

Project Updates

- FY14 (Belmont Village) Electric Service Upgrade Underground Wiring Glen Castro will update to include category to read: Community Housing.
- FY17 Preserving Belmont's Original Vital Records and Digitizing Belmont's Town Meeting Records Elizabeth Dionne asked whether these projects need extensions beyond the 30 months. CPC authorized the 30 months extension at a precious CPC meeting. Floyd Carman will follow up with Ellen Cushman on project status.
- FY18 PQ Playground Revitalization Project Phase 2 Julie Crockett will reach out to Floyd Carman regarding fundraising monies. Roy Epstein wanted to know why the project has not been completed or closed. Floyd Carman stated that the project remains open as fundraising money still exits and is waiting for project sponsor to turn over the money and defining and informing the Select Board how the money will be spent.
- FY19 Architectural Drawings for Music Bandstand at Payson Park Margaret Velie stated that we did get drawings from Tomi Olsen. Glen Castro will follow up with Jay Marcotte, Director of Public Works.
- FY20 Clay Pit Pond and Rock Meadow projects Margaret Velie stated that nothing has been done at this time.
- FY20 Community Path Phase 1b Roy Epstein stated that a meeting with MBTA and engineering firm is pending.

Other Business

- Administrative expenses Floyd Carman moved to approve Glen Castro's administrative expenses for Dec. Jan., passed unanimously.
