CPC Timeline to Town Meeting

Annual Town Meeting Report

CPC discussed the annual draft report by Elizabeth Dionne. Elizabeth Dionne stated specific edits should be sent to her. On page 7, under gatekeeping, Gloria Leipzig needed clarity as it reads "the CPA may modify its practices in several ways."
