2. Welcome of New Board Member: Mark Paolillo, who is a Former selectman in Belmont. He expressed a strong respect for the Council on Aging and the seniors of the town

Housing Board and Belmont Housing Trust will do about it. Judy and Tomi are going to those meetings. Maryann says they want to change original plan and would have to go to town meeting for approval. Concern is that units will be reduced in number and eligibility will be different . Traffic may be a problem. It is currently horrendous. Too many lights and traffic backups occur on Mill Street. Also there is a backup from Belmont Center. Roads are not designed to handle 2-3 times as many people coming out of there. There is a need for moderate to low income housing. At one meeting the builder expressed a desire to build more town houses. Adam Dash is Board of Selectman liaison. We should have questions and concerns for him when he comes.. We are asking Board Members on the Belmont Housing Trust to notify us of the meeting regarding the Belmont Housing property project. Cross town busing should be part of the project. Traffic issues have already been subject of work by Selectmen. Significant safety issues exist. Nava will draft letter to the Selectman about this. The group that was named the Traffic Advisory Committee for years is now the Transportation Advisory Committee with broader responsibilities.. We should express our safety concerns to them. Traffic is concern for seniors. Drivers being

There is a Kiosk project to be built by library carpenter. The kiosk will hold second monitor of My Senior Center. It will enable us to have people scan in as they come in and no lines at front desk. Community Development is too busy with other things and no one will be appointed. We will ask the Select Board whether they could suggest how Community Development could help. Assistant Director: Julia Child and Bocciburgers events each had more that 60 people attend, a book club and historical society event was great. Virtual reality, Revere Beach party were all good. Jane Peters at Media center will do a program. Dana Farber will do the Mammography van. Breakfast rollout on Mondays and Fridays. We want to collect attendance data. Active shooter training will occur with the BPD.

Police Chief Search Committee: Mark is chair of that committee. We have 5 people for interviews. Nov 2 another meeting. Likely 2 candidates will be presented to Select Board. A discussion of training officers to deal with the elderly was had. Police are especially good with elder abuse issues. Nava is not aware of internal training for police. Nava feels that Lt. Daley is on top of things. There is no mechanism of communication between Nava and the other officers.

Volunteer Driver Program: Open house; 13 people came, 6 handed in applications. Training is to start. Transportation numbers are down for September. One driver has been out. They had special trainings. People will drive when their schedule allows.
