Update- Town Structure Impact Group looking over the finance; issues of the Town. Anne Helgen from the committee asked about our budget back from 2015? Transportation is 30% of our budget. A. Helgen asked about outsourcing transportation to cab companies. Nava answered via phone her concerns, mentioning that seniors cannot do Uber, and our drivers are well trained. We provide more than what the Town budgets.

Why should the COA give rides? They help seniors be more independent. Our drivers are patient and understanding!!!

Our drivers are trained on how to handle Seniors. J. Semuels suggested A. Helgen check past Annual reports. Our Budget is 1% of the Town's budget!!! Our non-Town appropriation budget comes from donations -Friends of the COA, various donations, Grants and user fees. Judy will write a report. we have over 5k Seniors in Belmont!!

Oct 4th, Beech Street opened for first time on a Monday since COVID and was busier than A ever!!

Staff Appreciation Lunch-outside Ellen and Tomi are planning, Members of the COA are furnishing food and supplies!

6. Friends of the COA-Concert- J. Semuels reported more money raised over \$6,000! (net). Revenues included \$7900 in sponsorships.

There were 13 corporate sponsors and 6 family sponsors.

Next Event-Craft Fair Sat. Nov. 20th. K. Nichols is the coordinator. Only 30-35 vendors will be allowed in the event. The Friends' annual meeting will be held over Zoom.
