The event will include speakers from AARP, the AFAC Housing subcommittee, and a panel of various experts. Ellen Sullivan will be presenting a program on how to downsize to a smaller house or senior community and Steve Rosales will present on navigating the estate tax.

Other April activities include a presentation on the Wright Brothers, a Frank Sinatra tribute singer, and a talk centering on game theory in WWII. We will also have our first weekend trip on Saturday April 29th, as a group will head to the Boston Common to view "The Embrace" and go to lunch.
