Notes

Relocating mechanical mezzanine access ladder from the Janitor Closet B138B to the Corridor B100E to avoid clashes with coordinated ductwork, plumbing, fire protection, and mechanical piping. These instructions remove misc metal ladders from the job and replace with a drop down concealed stairway in this area.
