- Ara needs submission of drawings for an amendment to building permit for railings and door.
- Still not at substantial completion, Chair Mahoney asks what are our steps forward now?
- Multiple emails have gone back and forth and always have small issues, just seems that there is difficulty each time they interact with committee/designer
- Tom would like to schedule on-site meeting next week in order to put pressure on
- Member Smith inquires regarding training on systems? Ted answers that they have been instructed that all documents and manuals must be provided to DPW at least one week prior to any training sessions.

- Discussion regarding soil at PD
- Update regarding cell phone tower mast column was uncovered during demo, and question came up regarding what it was supporting? May have been original to the building, but cell tower is sitting on top of the column. Structural engineer requested to come out and investigate
- Town will pay for structural engineer
- Concern is over timing on repair if needed
- Discussion was had since previous meeting regarding furnishings for PD
- Furnishings trending in the 285K range. Substantial amount of that is equipment (lockers, storage, racks, etc.)
- Does not include tech/audio visual/security items, so that cost needs to be determined
- Security (card access, cameras, etc.) in contract documents we own pipe and path. We always contemplated having a different entity do the work to actually set up and run the systems. Proposal from town's vendor Galaxy came in over 200K. To do just the wires is 35K. Tom feels that it makes far more sense to run the wires while the walls are open. Steve Dorrance has security earmarked funds that he is willing to utilize to fund the wires while the walls are open.

- Member Ferrante inquires regarding status of front steps, have we had any update? No front work has been completed yet
