


**PROJECT OVERVIEW** 

We are seeking approval for repairs and improvements at 605 Pleasant St. a house in the Pleasant St. Historic District. Project consists of widening 3<sup>rd</sup> floor rear gable to create an additional office room on the home's third floor. This work is not visible from any public view.


All additional work consists of like kind repair and replacement to existing façade and exterior porch components. Below is a list of the repairs.


- **ROOF:** replacement of existing asphalt shingle roof. GAF Timberline HDZ Pewter Gray. Product Info attached (see page 7).
- **GUTTERS:** repair/replace wooden gutters, as required. Line with copper
- **WINDOWS:** replace street facing 3<sup>rd</sup> FL gable window. Marvin Ultimate Wood. Product Info attached.
- **SIDING:** spot repair/replace, as required. <sup>1</sup>/<sub>2</sub>" cedar clapboards.
- **FRONT PORCH DECKING:** new 1x4 vertical grain Douglas Fir decking.
- FRONT PORCH RAILINGS: increase railing height to 36", where required by code (30" above grade). Top/bottom rail to match existing profile, square fir balusters. Newel posts to match existing.
- **FRONT PORCH LATTICE:** install new square cedar lattice to below deck to match existing. Painted to match house body.
- **EXTERIOR PAINTING:** paint house exterior; colors to remain


