 - Current municipal organization chart;
 - Conducted interviews with personnel and elected/appointed officials;
 - Developed a list of comparable peer municipalities; and
 - Compared municipal practices to best practices (MGFPA and MMA).



Key Recommendations

- Follow DLS guidelines and established best practices during the annual budget process, which includes reaching consensus on all financial forecasts and the development of an annual financial cycle which identifies individual and board/committee responsibilities and a clear timeline for major aspects of the process;
- Create an organization that is more centralized through Select Board policy, bylaws, special legislation, and Massachusetts General Law; and
- Clearly define and strengthen the powers and duties of the Select Board and Town Administrator through Select Board policy, bylaws, and/or special legislation.
