- 2. Open Forum: There was no discussion under Open Forum this month.

#### 8. Unfinished Business:

1. Discussion of Housing Consultant: The board discussed the use of HOME funds for the purpose of hiring a consultant. The Belmont Housing Trust had previously voted that approximately \$16,000.00 in HOME funds could be used by the authority to do a preliminary analysis of the redevelopment potential of Belmont Housing Authority sites.

## 9. New Business:

- 1. Discussion of CPA Funds: The board agreed to review all projects for consideration for the Belmont Housing Authority application in 2016.
- Status of Maintenance Work Orders/Annual Inspections: The board unanimously agreed to hire an outside inspection company to do the annual inspections of all Belmont Housing Authority developments. It was also agreed that Tommasina Olson would review the open work orders, including tenant calls, emergency calls and annual inspections.
- 3. Visit to Roxbury Crossing: Commissioner Tommasina Olson will schedule the visit and advise the board of the date and time.
- 4. Section 8 Program: In the future, the authority may decide to convert some of the current vouchers to project based vouchers similar to the two (2) project based vouchers that are currently under lease with Beaverbrook Step.
- 10. Next Meeting: The board agreed that the next regular meeting would be held in the Town Hall at 5:30 p.m. on Monday, June 13, 2016.
- 11. Adjournment: A motion was made by Gloria Leipzig, seconded by Tommasina Olson, to adjourn the regular meeting at 7:25 p.m. The vote was unanimous (4).
