- 2. Open Forum: There was no discussion under Open Forum this month.
- 3. Reading and Approval of the Minutes of the Meetings:

## 5. Executive Director's Report:

1. Attendance: The Director will be responsible for submitting the board attendance on a monthly basis as required by dhed regulations.

### 6. Agenda Items for Board Vote:

- 1. Vote to Approve Certificate of Substantial Completion for 200-1 Underground Cables: A motion was made by Sallye Bleiberg, seconded by Leo Saidnawey, to approve the Certificate of Substantial Completion for the Underground Cables at Belmont Village. The vote was unanimous (4).
- 2. Vote to Approve Certificate of Final Completion for 200-1 Underground Cables: A motion was made by Sallye Bleiberg, seconded by Leo Saidnawey, to approve the Certificate of Final Completion for the Underground Cables at Belmont Village. The vote was unanimous (4).
- 3. Vote to Approve Application for Payment for 200-1 Underground Cables: A motion was made by Sallye Bleiberg, seconded by Leo Saidnawey, to approve the Application for Payment in the amount of \$1,325.00. The vote was unanimous (4).

# 7. Report of Committees:

- 1. CPA: The board briefly discussed the CPA Application process with regard to the Authorities' application for funds for the underground cables at Belmont Village.
- Belmont Housing Trust: Commissioner Charles Laverty briefly discussed that there would be a housing forum on November 1<sup>st</sup> and that he would also be attending a meeting with the Human Rights Commission on December 6<sup>th</sup> to do a joint presentation on the Belmont Housing Authority.

### 8. Unfinished Business:

1. Solar Panels: Commissioner Don Becker received a copy of the Solar Request for Proposals for the Belmont Public Schools and briefly reviewed the process that the Town is implementing. A motion was made by Leo Saidnawey, seconded by Sallye Bleiberg, that Commissioner Don Becker would be authorized to represent the Authority with regard to the solar installations for Belmont Housing Authority developments. The vote was unanimous (4). It was further agreed that Commissioner Don Becker would inquire about the storage agreement with BMLD prior to discussing this further with dhcd.

- 9. New Business: There was no new business to discuss this month.
- 10. Next Meeting: The board agreed that the next board meeting would be held in the Town Hall at 6:00 p.m. on Monday, November 26th, 2012.
- 11. Adjournment: A motion was made by Sallye Bleiberg, seconded by Charles Laverty, to adjourn the meeting at 6:30 p.m. The vote was unanimous (4).
