Reviewed the Communications, the past 3 years Site Visits, and previous tracks for areas not covered, and any recent Issues or Reserved Right Activity.

Based on Remote Imagery criteria, I selected 3 areas of interest to include in the Remote Imagery Report:

1 Mill St Area - There is a new 18' diameter structure that appears on the CR north of the Arlington School. However, the CR boundary linework does not match the level 3 parcel data and is off by 20' on this line, which puts the structure off the CR.

2 Pleasant St Area - No changes noted.

3 Great Meadow - No changes noted.

After careful imagery comparison of these areas and imagery comparison of the entire CR, there were no CR changes observed. The imagery was compared by methodically checking each section of the property with scale bar showing at least 100' scale.
