- 2. Invoices

Four invoices were presented for approval:

- a. Heritage Fields mowing Lone Tree Hill and barn area: \$3,000
- b. Parterre Ecological Treatment invasive plant management \$2,700
- c. Nunes mowing of Lone Tree Hill trials and Heart Shaped Meadow trials: \$425
- d. Calhess Restoration and Weather Proofing Corp. work on securing McLean Barn door: \$2,949

- 3. Erosion on Coal Road
  - a. Michael reported that McLean Senior Engineer walked the area with consultant and consultant did not see erosion resulting from the parking lot. There was erosion observed further down on the Coal Road and the consultant recommended filling the culverts with stone.

Radha noted that it had been reported that the erosion on the Coal Road was coming from water run-off from the parking lot. Michael said that the consultant believed that the water run-off system installed in parking lot system approved by the Town was working. Radha suggested that the next step be to have the consultant walk the site with Joe Hibbard. Michael agreed to connect Joe Hibbard with consultant.
