RE: Application for a Waiver to Erect a Sign - Project Statement

To Whom It May Concern:

My name is Dane Helsing and I serve as the Pastor of Beacon Community Church in Belmont, MA. Our church community purchased the property located at 368-380 Trapelo Rd in September, 2020. The middle portion of this three-parcel property is the former Studio Cinema located at 376 Trapelo Rd. We now hold our Sunday services there and all other functions and events integral to the life of our church (youth gatherings, community events, etc.) We would like to request permission to construct a sign on the white front exterior façade, which formerly held the "Studio Cinema" sign (blue script). A waiver is required for this sign replacement on the white façade because of the existing marquee below it. We would technically have two signs in this case, which would not abide by town regulations (Section 5.2.5 of the By-Law). Below is a written description of the sign we are hoping to erect followed by a brief narrative why the sign would not have an adverse impact.

- a. Written Description The sign will be our church's name "Beacon Community Church" with "At Studio Cinema" underneath. All letters will be in black aluminum and attached to the white exterior façade (see artwork). It will be 11 feet wide by 5.65 feet high covering a total area of 62 square feet. Currently, there are two small spotlights that shine on the white façade that illuminated the former "Studio Cinema" sign. We'd like to keep these to illuminate our church's name during evening hours (turned off by 10:00pm).
- b. Narrative of Non-adverse Impact Our church has invested in the town of Belmont from the day we started in September 2015. We have the word "community" in our church name because we want to be deeply engaged with our community. One of our hesitancies in purchasing Studio Cinema was the feeling of loss many of our neighbors

and community members would inevitably feel because a beloved community gathering place would no longer be in operation as they knew it. Upon the purchase, we had numerous conversations with folks in-person and on social media that confirmed this concern. We are sensitive to this reality and have worked hard to communicate to our neighbors that we empathize with them and want to invite them to join us for other enjoyable community events hosted at our facility in the days ahead. We want to include the phrase "At Studio Cinema" in black aluminum letters and keep the old marquee to thoughtfully commemorate the significance of the cinema to our community. Our proposed sign does not add a second sign to the property. Rather, it maintains a very similar feel to what has been there for decades (letters on a white façade with a marquee below it, see comparison below). Additionally, keeping the marquee would allow us to invite neighbors to upcoming services and events (like our monthly free movie Saturday) that they may be interested in. In short, we want to be good neighbors.



RE: Denial to Install Second Wall Sign

Dear Mr. Linders,

The Office of Community Development is in receipt of your sign application to install a second wall sign at 367 Trapelo Road, Beacon Community Church, located in Local Business III (LBIII) zoning district.

Your application has been denied because it does not comply with the current Town of Belmont By-Laws. More specifically, §5.2.5 5. c. considers a marquee as a sign in lieu of a wall sign and, §5.2.5 4. b) 1. of the By-Law allows the installation of more than one sign by a Special Permit granted by the Planning Board

The installation of the second wall sign is allowed by a Special permit granted by the Planning Board.
