Subject: Amend Order of Conditions to Remove Dugout Shelters at Baseball and Softball Fields

The Belmont Middle and High School Building Committee [Building Committee] is requesting temporary relief and an amendment to the Order of Conditions to remove dugout shelters at the baseball and softball fields as a condition to close out the open permit.

The Building Committee had plans in place to have the shelters installed this past summer. The Brendan Grant Foundation, following review of the shelter design, informed the Committee this past spring that they intended to install a different type of shelter to resemble the former baseball dugout shelters which were demolished in 2020. The Brendan Grant Foundation and Building Committee decided that it was not good use of taxpayer dollars to have new shelters removed so the Building Committee eliminated the shelters approved by the Planning Board from the project We approached the Planning Board this past June to discuss the alternate solution proposed by the Brendan Grant Foundation. Following further considerations of a new dugout shelter design, the Brendan Grant Foundation informed the Building Committee this past summer that they intended to use the shelters approved by the Planning Board and enhance them with a future project construction effort independent of the Belmont Middle and High School project. Unfortunately, the original shelters purchased in 2020 were canceled, so the Building Committee had to requote and approve a new order of shelters this fall, thus delaying the installation of the shelters until next spring.

The Building Committee is now committed to installing the shelters as presented to the Planning Board during the Site Plan Review meetings in 2019 and 2020. Evidence of that commitment is attached herein in documentation with Sportsfield Specialties Inc., the canopy vendor, that includes the signed cost estimate, submitted shop drawings, and the purchase order from the Town of Belmont. The expected schedule for delivery of these canopies is early spring and they will be installed immediately upon delivery in time for spring sports. Evidence of the delivery time frame from Sportsfield Specialties Inc. is attached herein.

It is the desire of the Building Committee that the Planning Board approve this request so that we can close out the project permit this year and begin the State audit effort which must be completed before we receive the final State grant payment. If the Planning Board grants this request, we will be able to accelerate this State audit by at least four months.

The Committee appreciates the Planning Board's consideration in this matter.




