#### **Fall Program Report: Brandon**

- We are in the middle of "Fall 2" so discussion is on first half of fall programming
- 571 registrations (may be same child registered for multiple items)
- Joint event movie with Council on Aging and Belmont Library was successful
- 36 house submissions for Halloween contest
- Tennis reservations
  - 159 hours at Winn Brook (86 registrations); 17 hours at PQ (10 registrations); 178 hours (85 registrations)
  - Some complaints and feedback about private lessons at Winn Brook and Grove Street
  - When we open the registrations up for spring, encourage usage at PQ (e.g., Belmont Hill)
  - o Future tennis discussion will happen ahead of the spring
  - Public meetings will be held in January and February for CPC project (500-foot radius from the park); youth organizations (including soccer)
- We have over 1,000 households in the system due to COVID/requiring registrations

#### **Skating Rink: Brandon**

- Belmont Hill and Belmont Day are in session and using the rink
- High school hockey is starting next week

#### **Recreation Update: Brandon**

- Schedule second meeting in January to invite tennis community for reservation and CPC discussions
- During meeting in February, will talk about strategic plan and general recreation commission business
- Brandon will reach out to commission members for 1:1s before January meeting
- Looking to summer will we have staffing issues in the summer for the pool?
  - Might have some challenges certifying (everybody's has expired) but we haven't lost staff to other pools (because they were all closed)
