Item 1: Meeting Minutes for January 23, 2023

- No changes
- In favor: Anthony Ferrante, Steve Colello, Steve Warner, Theresa O'Connor, and David Lind
- Josh Gould not present at time of vote

Item 2: Update on CPC Projects by Brandon Fitts

- Two projects to be voted on tonight in terms of support
 - (1) PQ Basketball Court
 - In-kind
 - Activitas not doing project, to be done by Waterfield Design Group (Town Field)
 - Update on pricing/design fees
 - Total construction cost around ~125k
 - (2) Grove Street Park
 - Baseball Fields & Basketball Court (+ fencing)
 - BF spoke with Jon Charwick (Activitas) and Elizabeth Dionne (CPC)
 - Soil top layer amount recommended by Activitas was also recommended by Friends of GSP
 - Question from SW: When was this discussed?
 - Per BF, last meeting with Friends of Grove Street Park (late 2022)
 - AF expressed support of sod option
 - Per BF, sod option not chosen because of cost and on the basis that there is better long-term health of field with soil option
 - Disadvantage to this soil option is that the fields will be out of commission longer
 - Belmont Youth Baseball looking at options
 - Higher cost in budget mostly due to fencing line item
 - Was left out of prior budget because there was confidence in grant funding that ultimately fell through
 - Per BF, ED of CPC is confident there is wiggle room within CPC
 - Question from AF: What's up with the fencing?
 - Old, rusted, in need of redo
 - According to Activitas, this is for all fencing around the park and the baseball fields
