### **Town Field Revision:**

Pickleball Revision draft: Jay and Brandon

- Additional cost is roughly \$4K (but change order might change the cost a little); there is reduction in fencing and extra asphalt
- Pickleball wants the corners 90 degrees (instead of flat corners like we have with tennis courts)
- Jay disagrees with additional permanent nets (Courts 3 and 4); pickleball courts can be multi use and if we have permanent nets, we reduce the flexibility of use

# Discussion

- Agree not to install extra permanent nets
- Even with the extra cost, it's below the allocated cost from the Community Preservation Committee (CPC)/Town Meeting
- Raised concern with setting a precedent for coming in with last minute changes post-approval
- Jay noted there's a change order with virtually all projects due to the nature of construction

- Joshua; Belmont resident for eight years, two kids at Chenery School (5<sup>th</sup> and 8<sup>th</sup> grades)

- Steve wasn't able to attend today
- Intro to the other Commission members: Paul (Chair; Year 4); Cortney (Secretary; six years?);
  Anthony (10 years; various roles in the past current liaison of the Rink Building Committee);
  David Lind (Vice Chair; 2<sup>nd</sup> year on Commission); David Kane (13 years; has had various roles;
  currently CPC liaison, two kids in college); Theresa (3<sup>rd</sup> year on the Commission)

# **Budget Conversations:**

Jennifer Hewitt: new Assistant Town Administrator/Finance Director

- Recreation (budget) is transitioning over; COVID-19 has affected timeline of programming and revenue; as we were building FY23 budget (current budget), we used conservative numbers and needed supplemental revenue
- Discussion between Brandon and Jennifer regarding enterprise or revolving fund; this needs to go through bylaw committee and warrant committee
- Budgets are due to FY24 by Friday; Patrice will issue her budget in February and wrap it up in March/April
- We use historic budget to determine future budget; it's better to have a full year of FY22 actuals (and FY23) to have a good solid budget
- There's currently a Town subsidy that supports Town staff; hope is this will eventually be eliminated

# **Age Friendly Action Committee:**

- Interdepartmental committee focusing on senior access in town; Theresa was our liaison but the times did not work for her schedule
- Paul can cover for a little while and then see if we can rotate, join every other meeting, or request a shift in time every so often
- Flexibility wise, nearly we're all working professionals so Thursdays at 11am makes it difficult

# **CPC Projects: September 2022 submissions:**

# **Grove Street:**

- Roughly \$1.3M for reconstruction of baseball fields and basketball court; Activitas is working on the numbers
- Will be moving forward with phase II construction proposal for current CPC cycle

#### Underwood Park:

- Going through phase I public process; hopes to do construction documents for future fiscal year
- No current citizen spearheading this (yet)

<u>PQ Basketball Court</u>: Looking to replace basketball court in kind; it was not done with the previous park renovation

# Potential Skate Park:

- Push for a skate park in town
- Question always comes up "where?"
- Wanted to do a design and feasibility study to see where in town this might fit, but was met with resistance at the CPC meeting
- CPC may not be able to fund all the projects (due to budgeting constraints)

 Discuss Underwood (playground) usage – Belmont Cooperative Nursery uses it, Wellington was using it

# **Dog Conversation Outline and Plan:**

Suzanne Trasavage: Animal Control Officer (still on maternity leave but called in)

- Need to meet with Suzanne and Board of Health policy bylaw names both departments
- From there, two public forums (more if needed) with clear agenda for topics and input
- Need to create a roadmap for discussions suggest having them in winter months (to put in place for warmer weather)
- Current fields that allow dogs: Town Field, PQ Park, Grove Street, Winn Brook
- The old program has only 200 dog tags available but there are many more dogs in town than that
- Theresa offering to be a part of the discussion
- Two public forums (Board of Health and Recreation Commission)
- Suggest Adam Dash, (Select Board Liaison) is in the loop on this
- Brandon will schedule some internal town meetings and then start the public meeting process
