#### NOTICE OF A PUBLIC HEARING

A Design Public Hearing will be held by MassHighway to discuss the proposed Trapelo Road / Belmont Street Corridor Improvements project in Belmont, Waltham, and Watertown, MA.

PURPOSE: The purpose of this hearing is to provide the public with the opportunity to become fully

acquainted with the proposed Trapelo Road / Belmont Street Improvements project. All views and comments made at the hearing will be reviewed and considered to the maximum extent

possible.

PROPOSAL: The proposed project consists of roadway, sidewalk, traffic signal and landscape improvements to

Trapelo Road from just west of Waverley Oaks Road in Waltham to Belmont Street in Belmont, and improvements to Belmont Street from its intersection with Trapelo Road to the Cambridge

Town line, a total distance of about 2.5 miles.

A secure right-of-way is necessary for this project. Acquisitions in fee and permanent or temporary easements may be required. The towns of Belmont, Waltham, and Watertown are responsible for acquiring all needed rights in private or public lands. MassHighway's policy concerning land acquisitions will be discussed at this hearing.

Written views received by MassHighway subsequent to the date of this notice and up to five (5) days prior to the date of the hearing shall be displayed for public inspection and copying at the time and date listed above. Plans will be on display one-half hour before the hearing begins, with an engineer in attendance to answer questions regarding this project. A project handout is available on the MassHighway website listed below.

Written statements and other exhibits in place of, or in addition to, oral statements made at the Public Hearing regarding the proposed undertaking are to be submitted to Frank A. Tramontozzi, P.E., Chief Engineer, Massachusetts Highway Department, 10 Park Plaza, Boston, MA 02116. Such submissions will also be accepted at the hearing. Mailed statements and exhibits intended for inclusion in the public hearing transcript must be postmarked within ten (10) business days of this Public Hearing.

The community has declared that this facility is accessible to all in compliance with the ADA / Title II. Requests must be made at least 10 days prior to the date of the public hearing.

#### WHAT IS A PUBLIC HEARING?

#### WHY A PUBLIC HEARING?

To provide an assured method whereby the Commonwealth of Massachusetts can furnish to the public information concerning the State's highway construction proposals, and to afford every interested resident of the area an opportunity to be heard on any proposed project. At the same time, the hearings afford the Commonwealth an additional opportunity to receive information from local sources which would be of value to the State in making its final decisions to what design should be advanced for development.

#### WHY NOT A VOTE ON HIGHWAY PLANS?

The hearings are not intended to be a popular referendum for the purpose of determining the nature of a proposed improvement by a majority of those present. They do not relieve the duly constituted officials of a State highway department of the necessity for making decisions in State highway matters for which they are charged with full responsibility.

#### WHAT DOES A PUBLIC HEARING ACCOMPLISH?

It is designed to ensure the opportunity for, or the availability of, a forum to provide factual information which is pertinent to the determination of the final alternative considered by the state to best serve the public interest, and on which improvement projects are proposed to be undertaken.

It is important that the people of the area express their views in regard to the proposal being presented, so that views can be properly recorded in the minutes of the meeting. These minutes will be carefully studied and taken into consideration in the determination of the final design.

#### **RIGHT OF WAY ISSUES**

A secure right of way is necessary for this project. Temporary construction easements may be required. Your municipality is responsible for acquiring all necessary rights in private or public lands. If your property is affected, your rights are fully protected under law.

#### 1. REASON FOR PROJECT

The completion of this project will serve local needs. The proposed enhancement will also be in the interest of others in the greater community, and provide for the public good.

#### 2. WHO CONTACTS ME?

Representatives of the municipality have already contacted or will contact you. They will explain the procedures used in acquiring any necessary rights in land.

#### 3. WHAT ABOUT DONATIONS? WHAT IS A RIGHT OF ENTRY?

Town officials will often seek donations, of parcels, where permanent rights are required. This procedure will minimize the acquisition cost for your community.

A Right of Entry is a document that is signed by the owner. It allows the Contractor to perform certain types of work on the owner's land. The work is usually minor in nature and frequently consists of loaming/seeding behind sidewalks, new driveway apron work, grading/sloping, and wetland protection, etc. The rights granted are temporary in nature.

#### 4. WHAT IS A FAIR PRICE FOR THE ACQUIRED PARCELS?

In the event that donations are not considered, or completed, every effort will be made to ensure that an equitable value is awarded. Municipal and/or outside appraisers will complete an appraisal. Consideration is given to the type of rights needed, whether in fee, permanent or temporary easements. The appraisal will be the basis for arriving at a fair price (for damages that result).

#### 5. MUST I ACCEPT THE MUNICIPALITY OFFER?

No, if the owner feels that the offer is not fair the owner may petition the courts. This action does not stop or delay the acquisition. The action must occur within 3 years. The owner(s) may be paid pro tanto (for the time being). The pro tanto payment will not prejudice the court's final decision.

Trapelo Road / Belmont Street Corridor Improvements Belmont, MA

#### PROJECT DESCRIPTION

The Project consists of the improvements to the Trapelo Road / Belmont Street corridor through the Town of Belmont and sections of Waltham and Watertown. More specifically, Trapelo Road from just west of Waverley Oaks Road in Waltham, to its intersection with Belmont Street in Belmont, and improvements to Belmont Street from its intersection with Trapelo Road to the Cambridge Town line, a total distance of about 2.5 miles. In general the project will:

- Provide a roadway width that is consistent with the number of lanes of traffic. In some areas the
  pavement width will be narrowed and the sidewalk width increased, in other areas the roadway
  width will be widened and the sidewalk width narrowed.
- Provide bicycle accommodation for its entire length.
- Replace old and often substandard traffic signal equipment with modern fully actuated systems.
- Put closely spaced signalized intersections into coordinated systems.
- Improve the level of service at five of the highest volume intersections on the corridor.
- Improve pedestrian access by providing new and, in some areas, widening sidewalks and by providing sidewalk bump outs that shorten the crosswalks.
- Improve access to individuals with disabilities by bringing all wheelchair ramps up to current standards.
- Rehabilitate a worn pavement by removing the old surface and replacing it.
- Replace worn and cracked sidewalks.
- Provide additional street trees.
- Replace the failing Beaver Brook Culvert with a system that will carry the 50 year storm.
- Provide fire preemption along the corridor.
- Provide a trackless trolley priority system.
