There are a few items worth mentioning:

• MassDOT is in the process of reaching an agreement with HNTB to prepare the plans, special provisions, and estimates for the relocation of some of the MBTA catenary poles and overhead wiring system in the corridor. These documents, when completed, will be submitted for review and included in the contract documents for the next (PS&E) submission.

The design of the intersection of Belmont Street at Arlington Street and Grove Streets
has changed significantly since the 75% Submissions due to concerns expressed by
Watertown residents at the public meeting and the inability to obtain the land

necessary for the 75% design

• The design of the intersection of Belmont Street at School Street has changed significantly since the 75% Submission due to concerns expressed by the Watertown residents and the inability to take land from an island within the roadway layout that turned out to be of historical significance.

• The project is presently scheduled to be advertised in July of this year.
