Article 2: Authorization to Represent the Town's Legal Interests

The Select Board agreed that Article 2 should be supported. The Article has been discussed before and the Article involves a simple proforma change.

Motion was made for favorable action by the Select Board on Article 2. Motion was approved by a vote of 3-0.

Article 4: Amend General By-Law § 60-32 Demolition Delay

The Select Board agreed that the Article 4 amendment should be supported. The Article has been discussed before. The amendment proposes to remove a sunset clause in the bylaw.

Motion was made for favorable action by the Select Board on Article 4. Motion was approved by a vote of 3-0.

Article 5: Amend General By-Law § 40-100 Membership of Town Committees

This amendment was submitted by Town Clerk, Ellen Cushman. The amendment requires members of Town Committees to be residents of Belmont. Dash noted that this requirement is already part of the procedure for Town Committees.

Motion was made for favorable action by the Select Board on Article 5 as amended. Motion was approved by a vote of 3-0.

Article 6: Amend General By-Law § 60-325 Stormwater Management and Erosion Control

This amendment brings Belmont into compliance with the US Department of Environmental Protection and the Mass. Environmental Protection Agency requirements.

Motion was made for favorable action by the Select Board on Article 6 as amended. Motion was approved by a vote of 3-0.

Article 7: Acceptance of Public Way: Oakmont Lane

The Select Board is required to vote on supporting this Article, before it goes to Town Meeting. It is a purchase and sales agreement that was executed with developer.

Motion was made for favorable action by the Select Board on Article 7. Motion was approved by a vote of 3-0.

Article 9: Special Act: Retail Liquor Licenses

This special act establishes that the number of alcohol licenses allowed in Belmont will remain at four (4) and wine and beer licenses will change from seven (7) to six (6). Only wine and beer numbers are being amended. The Article incorporates the amendment language.

Motion was made for favorable action by the Select Board on Article 9. Motion was approved by a vote of 3-0.

Article 10: Special Act: Relating to the Retirement Classification of Certain Employees in the Town of Belmont

This Article affects eight current employees and was discussed in length at two prior Select Board meetings by Tom Gibson, Chair of the Belmont Retirement Board.

Garvin said that Article 10 was amended to include positions that were left out of the original Article. Dash made an additional motion to address this change.

Motion was made for the Select Board to reconsider the vote on Article 10. Motion was approved by a vote of 3-0.

Motion was made for favorable action by the Select Board on Article 10 as amended. Motion was approved by a vote of 3-0.

Article 11: A Resolution in Support of Changing the State Flag and Seal of Massachusetts

Dash said the petitioner had never discussed this resolution with the Select Board, but from what he has read about it, he would support it. Epstein said he generally does not support non-binding resolutions.

Motion was made for favorable action by the Select Board on Article 11. Motion was approved by a vote of vote 2-1. Epstein abstained from this vote.

Article 12: Amend General By-Law § 40-25 Encouraging Public Participation

This is a resolution and not a bylaw change and it does not apply to elected boards. The Article will not be placed on the Town Meeting Warrant until a week from tonight. The Select Board would like to have further discussion on this citizen petition and table the vote to a later meeting.

Robert McGaw, the citizen who submitted the amendment, joined the meeting. He confirmed that this amendment never applied to elected boards, only appointed boards.

<u>Discussion and possible vote to sign Community Preservation Act (CPA) Grant Agreement for the Belmont Housing Trust</u>

Betsy Lipson, Co-chair of the Belmont Housing Trust joined the meeting. This agreement is in regards to funds that were provided by Town Meeting a year ago. At that time, Town Meeting approved shifting grant funds to an emergency rental fund. The approval from the Select Board will allow for the Housing Trust to move forward with bids from developers.

Motion was made for the Select Board to approve and sign the Community Preservation Act grant agreement for the Belmont Housing Trust, as presented, with an amendment that the first paragraph be changed from the "Board of Selectman" to "Select Board." Motion was approved by a vote of 3-0.

Accept resignations from Wayne Haley from the Belmont Emergency Management Agency and as Chair of the Local Emergency Planning Committee

Wayne Haley is resigning these positions due to his recent change from Assistant Fire Chief to Captain.

Motion was made for the Select Board to accept the resignation of Wayne Haley from the Belmont Emergency Management Agency and as Chair of the Local Emergency Planning Committee. Motion was approved by a vote of 3-0.

<u>Discussion and possible vote for appointment to the Belmont Emergency Management Agency – A.</u> Tobio

New Assistant Fire Chief, Andrew Tobio will become the Director of the Belmont Emergency Management Agency. The Local Emergency Planning Committee members will appoint the Chair of their committee. Assistant Chief Tobio spoke about his new role. Paolillo suggested that the Emergency Planning Committee present information about the committee at an upcoming Select Board meeting. Garvin said that she and Assistant Chief Tobio would review the charge of the committee. The Select Board also discussed the possibility of a Select Board liaison member joining the Emergency Planning Committee.

Motion was made to appoint Assistant Fire Chief Andrew Tobio to the position of Director of the Belmont Emergency Management Agency. Motion was approved by a vote of 3-0.

<u>Discussion and possible vote to sign Intermunicipal Nursing Services Agreement Between the Towns of Belmont and Arlington</u>

Town Administrator Garvin and Director of Health Department Wes Chin reported that this involves a long-standing agreement with Lexington to share one health nurse. Lexington had decided that they wanted to change this position to 40 hours and made the decisions to no longer share the nursing services with Belmont. After reaching out to other nearby towns, they learned that the Town of Arlington is willing to share a nurse. The employee will belong to the Town of Belmont. Salary split will be 40% support from Belmont and 60% support from Arlington. The employee will be the same person as originally retained in this position.

Motion was made to sign the Intermunicipal Nursing Services Agreement Between the Towns of Belmont and Arlington as presented. Motion was approved by a vote of 3-0.
