90 Agassiz Avenue (GR) – Mr. Kiyoshi Momose and Lucianna Ascanio Momose The Applicants request Three Special Permits to construct a two (2) story rear addition at 90 Agassiz Avenue located in General Residence (GR) Zoning District.
