The Planning Board will hold a public hearing on Tuesday, January 18, 2022 at 7:00 PM by remote access through the Zoom app. to consider the application of Patrick and Jennifer Murphy to construct a first and second story addition at 41 Cedar Road, located in the Single Residence C (SR-C) Zoning District. Special Permits: 1.- §1.5.4C (2) of the Zoning By-Law allows alteration and expansions of larger than 30% in the SR-C district by a Special Permit granted by the Planning Board. 2.- §4.2.2 of the By-Law requires a minimum side setback of 10.0', the existing side setback on the west side is 8.9' and the proposed is 8.8'. A Special Permit is required.
