- renovate the two circular landscape beds at Highland Meadow Cemetery with shrubs and perennials suitable for the site. Plant materials per the original Highland Meadow planting and landscape plant list.
- Perform pruning and clean-up of the landscape border for Highland Meadow Cemetery that runs from the entrance gate to the corner at the Day School driveway
- Optional work: install dwarf shrubs to restore the hedge at Belmont Cemetery Veterans' area at the back of the cemetery, two options: one side of walkway and both sides of walkway
- Update on Stantec project at Highland Meadow undertaken in FY20
- Financial Review of Dedicated Cemetery Accounts
- Review Overtime budget prepared by DPW for FY20 and FY21, both revenue and expense. Consider the Saturday overtime fee charged for Saturday funeral services and short notice funerals, possible vote to change that fee effective FY21.
- Consideration and vote on request by Town Administrator to transfer \$25,000 from Cemetery Perpetual Care Interest Account to General Fund to help defray cost of Cemetery Maintenance for Perpetual Care activities.
