Minutes

7:03 pm Meeting Opened by Larry MacDonald

Committee tabled request for Handicap Parking Space at 17 Hull Street to a later date as petitioner could not attend.

Jay Marcotte brought up an issue raised today over email about cars intruding into bicycle lane along a stretch of Concord Ave between Cottage Street and Myrtle Street. Two police officers are needed on duty during high school construction. Belmont Police Department will look into increasing enforcement of bicycle lanes. High School Traffic Working Group commissioned a consultant study on moving bicycle lane closer to the curb along Concord Avenue. That option is being explored.

Jeff Roth raised the option of removing the on-street parking along Concord Avenue at least during construction period. The parking makes it unsafe for cycling in conjunction with thru-traffic.

In the short term, the Belmont Police Department will try barrels and see how it works.

**7:15 – 7:25** Request for Two Hour Parking – 161-173 Belmont Street

Bob Warner, owner of one of the businesses presented the petition. The stretch of businesses along Belmont Street there includes a dentist, a lice-removal business, a hair salon, a laundromat, a yoga studio, and a children and family center. Every business has customers there for more than an hour. The surrounding blocks all have two hour parking.

TAC members requested information about the history of the one-hour parking regulations but no ex-officio member could provide information. Jamie MacIsaac shared that typically the request is for shorter parking to allow for increased customer turnover.

Acting Chair Larry MacDonald noted that we don't want to discourage customers from doing business in the squares and along Belmont Street.

A motion passed unanimously to recommend that the request for a Two-Hour Restriction for the block of 161-173 Belmont Street be approved by the Select Board.

**7:25 – 8:00** Request to Eliminate Two Hour Parking – Lewis Road

Petitioner Curtis Eames of 26 Lewis Road presented a question to the Committee about the origin of the 2-hour parking restriction and a complaint about the timing and methods of enforcing the restrictions starting in June of 2019 that has adversely affected himself and other residents of Lewis Road. Members of the public, representing 15-17 Lewis Road, 22 Lewis Road, 26 Lewis Road, and other addresses, shared similar frustrations. Most residents have single lane driveways and need to stack cars; they need to be able to park their cars on the street.

Specific concerns about enforcement included:

1. Concern that cars were being ticketed even when they had been moved in and out of a spot several times over a two-hour enforcement period, suggesting that enforcement methods were inadequate to track the movement patterns of residents.
2. Concern that cars were ticketed when parked in front of houses that lacked 2 hour parking restriction signage.
3. Concern that enforcement increased suddenly and seemingly without adequate notification to residents.

Additional concerns related to parking voiced included:

1. Parking is occasionally too close to driveways.
2. The "No Parking Here to Corner" sign is missing and creating dangerous turning conditions.

Larry MacDonald gave the history of the road. Residents petitioned for 2 hour parking signs years ago to reduce commuter parking on the road. In June,

complaints were increasing about parking concerns so the police department initiated an increase in parking enforcement. A resident confirmed that the signs have been in place since the 1990s at least.

Jamie MacIsaac noted that this is a law enforcement issue. Police officers come with enforcement options and parking control officers write tickets for parking violations on parking signs and unposted parking regulations. On May 30, 2019, the Belmont Police Department put out a map on Facebook and Twitter notification that PCOs would enforce all parking signs and unposted regulations.

Jessie Bennett reminded the petitioners that the two-hour parking restriction is that you cannot park in a two hour zone for more than two hours over the course of a twenty four hour period.

Residents also requested clarification on options for addressing the parking issue offering the following options:

1. Selective enforcement of parking restrictions only for non-residents.
2. Resident parking stickers for Lewis Road residents.
3. Townwide resident parking permits.
4. Enacting regulations on parking distance from driveways.

Based on the resident concerns over parking enforcement, acting chair Larry MacDonald recused himself from further deliberation due to his role as a senior Parking Control Officer and assigned Jessie Bennett as acting chair for the remainder of the agenda item.

TAC clarified that the Committee cannot change Town bylaws or make recommendations to change Town bylaws. TAC can make recommendations to the Town Select Board.

TAC and Belmont Police clarified that the Committee cannot recommend selective enforcement of parking restrictions for non-residents only as this generates town-wide ramifications. Only Town Meeting can enact new bylaws that would create resident permit parking townwide.

TAC would be able to consider a petition to remove the two-hour parking restriction on Lewis Road. Because the petitioners came to the meeting without making a formal petition or collecting signatures, the acting TAC Chair, Jessie Bennett, recommended that they submit a formal petition to Glenn Clancy, Director of Community Development, the Town Administrator, Patrice Garvin, and the Select Board. That petition would then initiate a public hearing with notice to the abutters and result in a recommendation to the Select Board to

remove the two-hour parking restrictions on Lewis Road. TAC members, while inclined to resolve the issue in favor of removing the restrictions felt that a formal petition and hearing would be a more transparent process and would allow for greater clarity of the issue before the committee among the abutters.

Considerations raised by residents influencing TAC to be inclined to recommend removal of the restrictions include the following:

1. The MBTA bus stops have changed since the restriction was originally put in place, potentially reducing the attractiveness of Lewis Road as a commuter parking location.
2. The lack of commuter parking as a problem during the extended period of low enforcement of parking restrictions.
3. The lack of commuter parking or need for parking restrictions in the neighboring streets or area immediately adjacent to the area of two-hour parking restrictions.

Residents were informed that they could request a six-month trial of signage removal to see whether commuter traffic emerged as a significant problem in the absence of signage.

Town Staff agreed to conduct follow up on the issue in the interim:

1. The Department of Public Works agreed to review when signage was last installed and whether "No Parking to Corner" sign needed to be reinstalled on Lewis Road.
2. The Belmont Police Department and Parking Control agreed to review parking enforcement procedures and ensure that enforcement on Lewis Road is following proper procedures.
3. Parking Control agreed to explore the use of tracking locations of air valves on tires to identify cars that have been moved within a two-hour period to reduce improper ticketing.

Residents interested in contesting tickets were instructed to bring their complaint and evidence before the Parking Clerk in an appeal. TAC is not authorized to review or recommend waivers on parking tickets.

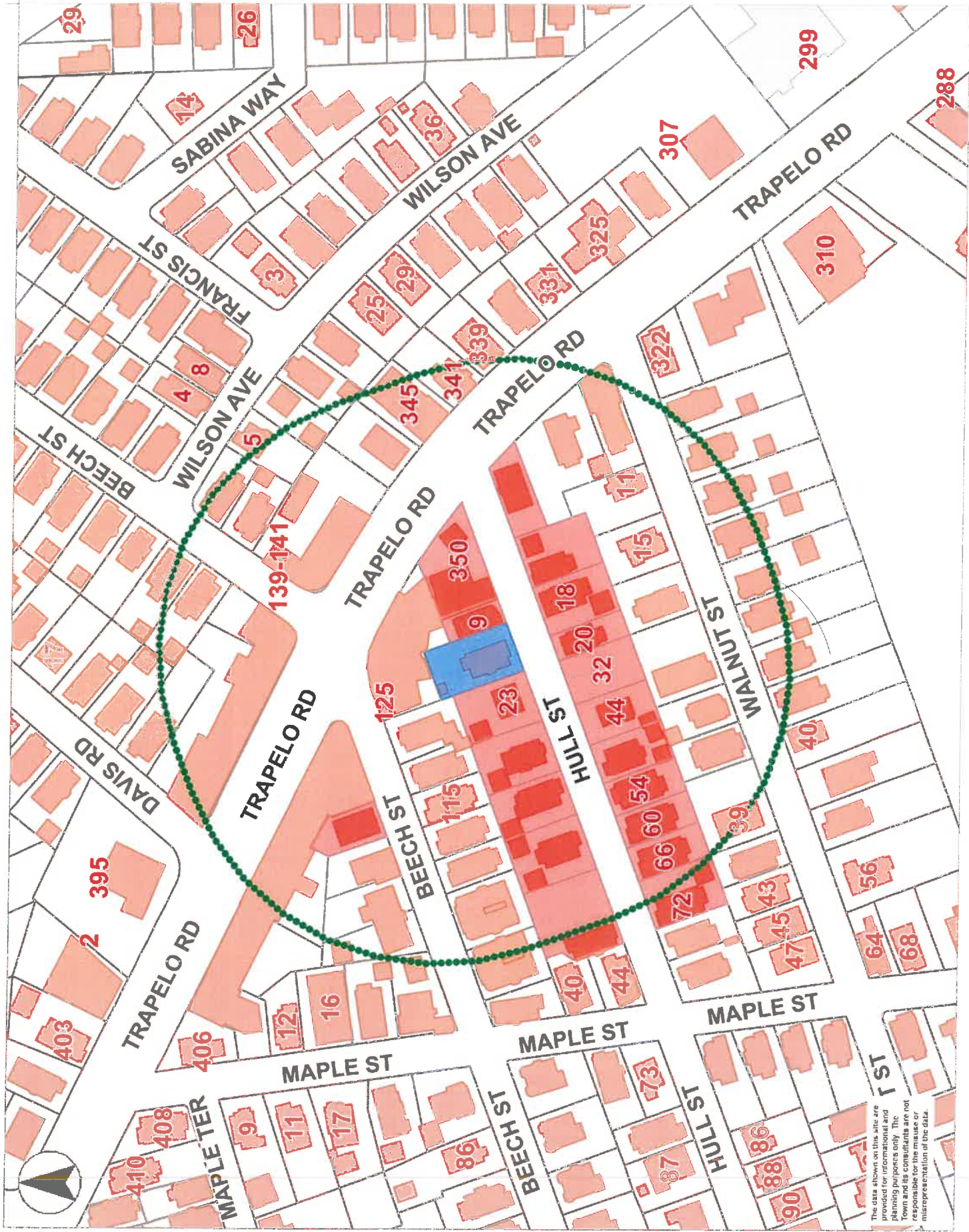

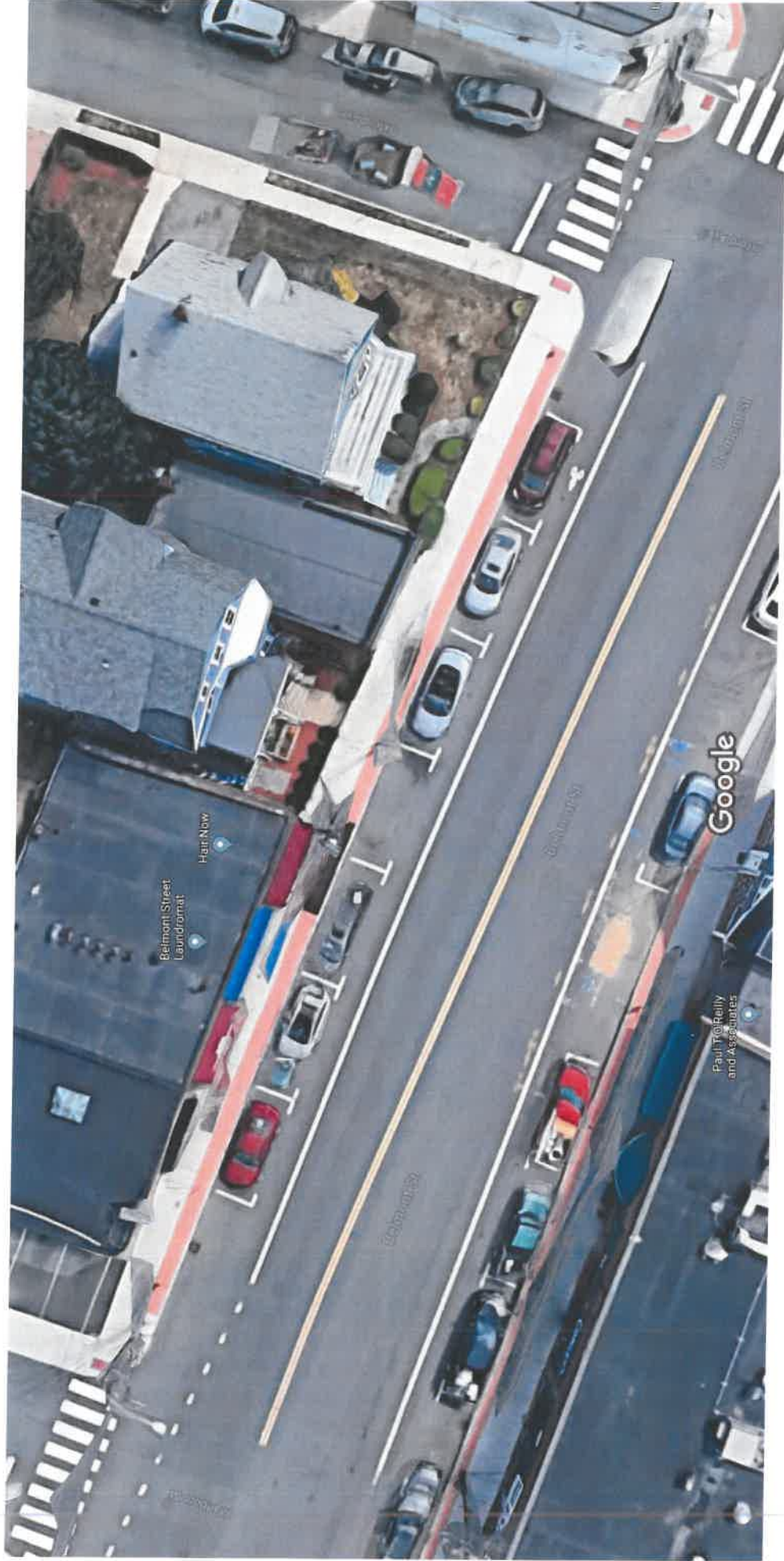
