- 1. <u>Attendance</u>: The attendance was taken at 6:00 P.M. Commissioners Don Becker, Sallye Bleiberg, Ann Verrilli and Donna Brescia were present. Also present were the Executive Director, Donna Hamilton; Anne Allen from the League of Women Voters; and residents of Sherman Gardens Apartments. Commissioner Leo Saidnawey was absent.
- 2. <u>Meeting with Residents of Sherman Gardens Apartments</u>: The residents in attendance indicated that they were happy with the development and had no issues to discuss with the board.

#### 3. Reading and Approval of the Minutes of the Meetings:
