PROPOSED PAINT COLOR CHANGE AT 710 PLEASANT STREET

BHDC recommended that the owners either select an appropriate color from Historic New England's period paint chart or have a paint analysis done and choose accordingly from the proposed colors based on the result. The BHDC will obtain the HNE color chart for the owners.

2. REVIEW PLANS AND MATERIALS FOR CHIMNEYS AT 5 SOMERSET STREET Regarding plans and materials for the reconstruction/restoration of the chimneys: The chimneys have been taken down and the brick saved. A list of work and timeline are attached herewith. Tom Saltzman, Architect brought in samples of the new bricks to be used to supplement the old bricks in restoring the chimney.

Motion made, seconded and approved: To allow for the exact reconstruction of the chimneys with the brick material as proposed.

(Note: Consider putting an item in "Design Guidelines" to deal with procedure when Owner has to contend with a disintegrating structure. BHDC needs to be notified ahead of time as well as the Town Building Department.)
