#### PETITION FOR UNDEGROUND CABLE LOCATIONS

December 9, 2020

To the Select Board

in **BELMONT**, Massachusetts

**VERIZON NEW ENGLAND, INC.** requests permission to locate underground cables and fixtures including the necessary sustaining and protecting fixtures to be owned and used in common by your petitioners, along and across the following public way or ways:

#### **White Street:**

Place one (1) four-inch (4") PVC conduit approximately 151'. Beginning at existing pole, P.25 and extending 125' in a southwesterly direction thence turning westerly crossing White Street for 26' to the property of 481-491 Trapelo Road.

This petition is necessary in order to accommodate new construction.

Wherefore they pray that after due notice and hearing as provided by law, they be granted joint or identical locations for and permission to erect and maintain poles, wires and cables, together with anchors, guys and other such sustaining and protecting fixtures as they may find necessary, said poles to be erected substantially in accordance with the plan filed herewith marked-VZ N.E. Inc. Plan No. **1A3V9NM** Dated **February 5, 2021.** 

Also for permission to lay and maintain underground laterals, cables and wires in the above or intersecting public ways for the purpose of making connections with such poles and buildings as each of said petitioners may desire for distributing purposes.

Your petitioners agree that space shall be reserved and maintained for the limited purpose of attaching one-way low voltage fire and police signaling wires owned by the municipality or governmental entity for public safety purposes only.

#### ORDER FOR CONDUIT LOCATION

By the Select Board of the Town of BELMONT, Massachusetts.

Notice having been given and a public hearing held, as provided by law, It is HEREBY ORDERED:

That permission be and hereby is granted VERIZON NEW ENGLAND INC. to lay and maintain underground conduits and manholes, with the wires and cables to be placed therein, under the surface of the following public way or ways as requested in petition of said Company dated the **5th** day of **February**, **2021**.

#### White Street:

Place one (1) four-inch (4") PVC conduit approximately 151'. Beginning at existing pole, P.25 and extending 125' in a southwesterly direction thence turning westerly crossing White Street for 26' to the property of 481-491 Trapelo Road.

This petition is necessary in order to accommodate new construction.

Substantially as shown on plan marked- VZ N.E. Inc. No. **1A3V9NM** dated **February 5, 2021 -** filed with said petition. Also, that permission be and hereby is granted said VERIZON NEW ENGLAND INC. to lay and maintain underground conduits, manholes, cables and wires in the above or intersecting public ways for the purpose of making connections with such poles and buildings as it may desire for distributing purposes.

The foregoing permission is subject to the following conditions:

- 1. The conduits and manholes shall be of such material and construction and all work done in such manner as to be satisfactory to such municipal officers as it may appoint to the supervision of the work, and a plan showing the location of conduits constructed shall be filed with the Town when the work is completed.
- 2. In every underground main line conduit constructed by said Company hereunder one duct not less than three inches in diameter shall be reserved and maintained for the limited purpose of attaching one-way low voltage fire and police signaling wires owned by the municipality or governmental entity for public safety purposes only.
- 3. Said Company shall indemnify and save the Town harmless against all damages, costs and expense whatsoever to which the Town may be subjected in consequence of the acts or neglect of said Company, its agents or servants, or in any manner arising from the rights and privileges granted it by the Town.
- 4. In addition said Company shall, before a public way is disturbed for the laying of its wire or conduits, execute its bond in a penal sum of Ten Thousand Dollars (\$10,000) (reference being had to the bond already on file with said Town) conditioned for the faithful performance of it duties under this permit.
- 5. Said Company shall comply with the requirements of existing by-laws and such as may hereafter be adopted governing the construction and maintenance of conduits and wires, so far as the same are not inconsistent with the laws of the Commonwealth.
