1008	2245	RFI-1947 RELOCATE OUTLETS FOR LABBB ADULT CHANGING STATIONS	\$922	The cost in this PCO is to relocate (2) power outlets. The original installation location did not allow the adult changing stations, which have an electric height adjustment feature, to travel to the full extent available.
