The original filing of the above-referenced campaign finance report is being amended for the following reason(s):

1. This amended report includes complete occupation and employer information for individuals who donated over \$200 to the Committee to Elect Roy Epstein.
2. This amended report separates out donations from couples that were incorrectly combined as a single donation. Such donations should have reflected both donors, not just an individual.
3. This amended report provides the address for one donor who had previously listed only a P.O. Box.
4. The original report inadvertently omitted a \$125 donation from January 31, 2019, which is now included.
5. The original report incorrectly included expenses of \$50.03 that were not actually incurred.
6. The original report incorrectly listed an ending debit balance of \$728.78. The Committee's account was never over-drawn, due to contributions from the candidate, who covered some campaign expenses. All expenses and in-kind donations are now correctly included in either this report or the campaign's final report submitted on 5/2/2019.
