The Town faced budget cuts and a budget override failure due to COVID-19, which resulted in staffing impacts such as the loss of 3 employees in the Engineering Department and the DPW. This resulted in a loss of resources to complete several requirements, and these requirements will be prioritized for completion in the Year 4 permit term.
