Discussion of draft Final Report

Discussion commenced regarding the process for reviewing the draft Final Report, including that
there should no longer be any substantial write-ups added, that Travis Franck will merge batches
that have been fully reviewed, etc.

- Discussion ensued about Working Groups developing a first draft of an Executive Summary, including the following points:
 - Vicki Amalfitano commented that the Revenue, Budget and Town Services Working Group will meet to put ideas under themes and identify ideas that have the highest impact
 - o The committee agreed that all Working Groups should start with this approach
- Matt Gasbarro shared document '2022-03-11_SCIG_REV_Projects.xlsx' and discussion ensued about the Index Table for inclusion in the Final Report, including the following points:
 - Matt Gasbarro commented that the important fields in the Idea Matrix which will feed into the Index Table are Title, Next Step, Scores, Dept/Area, Theme, and Report Author
 - Each Working Group will update these fields for their line items in the spreadsheet
- Travis Franck shared document 'SCIG Final Report (Draft-220308)' and made edits during discussion.

 - Joe Bernard suggested increasing the Ease of Implementation score; the committee agreed to change the Ease of Implementation score to 4

 - Paul Rickter suggested defining "Deltas" in the Background Information
 - Idea #81 Restructure Library Staff
 - Mark Paolillo suggested naming who will be responsible for continuing to evaluate staffing needs and models

 - Aaron Pikcilingis suggested clarifying language for the third bullet point in the Next Steps section
