## **Discussion of Executive Summary**

The working group discussed the process of creating the executive summary of the SCIG final report. Rickter noted that it will include some tables of ideas sorted by various criteria. Pikcilingis showed the matrix and the working group reviewed the **In Exec Summary** column, which will result in these ideas being included in the executive summary.

Some ideas were already flagged to be included in the executive summary during the work on an interim report from the committee. There was discussion about whether idea 410 (Rebuild the Library) should be included in the executive summary and the relative costs of renovating vs. constructing a new building. We agreed not to include the library idea in the executive summary. We agreed to add idea 79 (Combine Higginbottom and Underwood Pool Operations) and 346 (Get More Collins Center Help) to the executive summary.
